This publication presents the most recently available economic, financial, social, and environmental indicators for the 49 regional members of the Asian

This 54th edition finds that an estimated 155.2 million people in developing Asia and the Pacific, or 3.9% of the region's population, lived in extreme poverty as of last year—exceeding pre-pandemic projections by about 67.8 million people. The report finds that poor people have been most hurt by the increased cost-of-living crisis and provides an in-depth examination of the challenges they face in having to pay a premium for many essential goods and services.

○ **Asian Development Outlook April 2023 : Economic Forecasts for Asia and the Pacific**

ADB forecasts faster growth for developing economies in Asia and the Pacific this year, as the continued easing of pandemic restrictions boosts consumption, tourism, and investment. The People's Republic of China's reopening is the main factor brightening the region's growth prospects. Economies in the region are projected to grow 4.8% this year and next year, improving on the 4.2% growth rate in 2022, according to ADB's flagship economic report, the Asian Development Outlook - April 2023. The report includes economic forecasts and analysis for 46 economies in Asia and the Pacific.
